Readiness

Global Risk Data provides an invaluable knowledge hub for the latest news and insight on the risks covered; offering advice on kidnap prevention, country risk, as well as details on previous incidents in every location around the world. Policyholders could also qualify for an enhanced risk mitigation allowance of up to 20% of their premium spend. Eligible policyholders can reinvest this allowance in additional security related services, which could help protect them from future risks.



Response

Recovery

Kidnap and ransom insurance will reimburse all covered costs associated with an insured event (up to the policy limit):

- --- ransom costs including confiscated or stolen ransom;
- additional resolution expenses e.g. cost of public relations;
- —— liability costs arising out of the incident;
- —— death or injury (sub-limit);
- —— reasonable rest and rehabilitation (sub-limit).

Personnel Security Plus cover

Personnel Security Plus provides crisis management services to organisations and their employees in three phases – readiness, response and recovery.

Personnel Security Plus is not just for employees operating in high-risk territories; many of the risks covered such as workplace risk, cyber stalking and civil commotion can and do take place in stable, developed countries.

- As part of the readiness phase, Personnel Security Plus provides access to Control Risks' 24-hour Global Risk and Operations Centre for immediate advice and support. Other services include research and analysis conducted by geo-political, security, and cyber analysts, as well as web and social media scanning relevant to a threat or insured event.
- Crisis management. In the response phase to an incident, Personnel Security Plus policyholders will benefit from the immediate engagement of crisis management experts, either remotely, to their location or other agreed location.
